Letter from the Chief of Police

Mayor Inman, City Administrator Coker, City Council Members and Citizens of Macomb:

It is my pleasure to present the 2019 Annual Report. The professional men and women of the Macomb Police Department worked tirelessly in 2019, to maintain our greatest asset, public trust. Additionally, we continued to provide contemporary policing based upon best practices and high standards. Our Mission and Values remains the anchor of our services and we pride ourselves with making Macomb a great place to live, work and play.

This report provides a summary of the activity and accomplishments of the Macomb Police department during the past year. In 2019 the Macomb Police Department received 16,905 calls for service. This was a slight increase from 16,792 calls for service in 2018. Over the last five years the Macomb Police Department has seen calls for service increase each year. In 2014 the Macomb Police Department received 14,764 calls for service. This is an almost 15% increase in calls for service from 2014 to 2019.

The importance of a partnership between the police and community can't be overstated. It is through this partnership that Macomb has maintained a very low crime rate. The hard work and dedication of our police officers, professional support staff and community partners has resulted in our crime statistics staying constant over the last 5 years. You will see the number of incidents fluctuate each year but stay relatively consistent. You will also find additional statistical data on city ordinance violations, traffic enforcement, traffic accidents, sex offender registration and use of force.

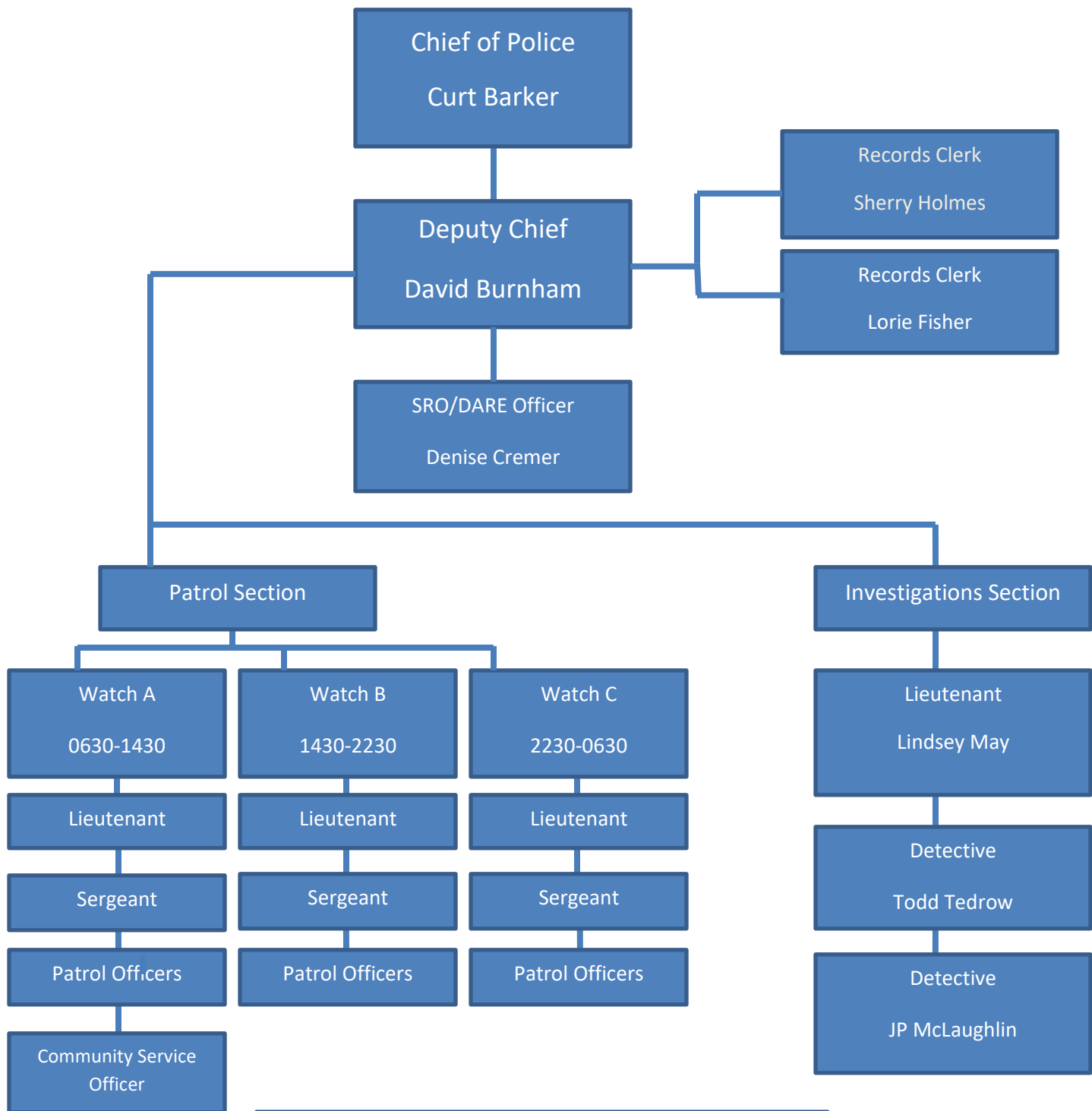

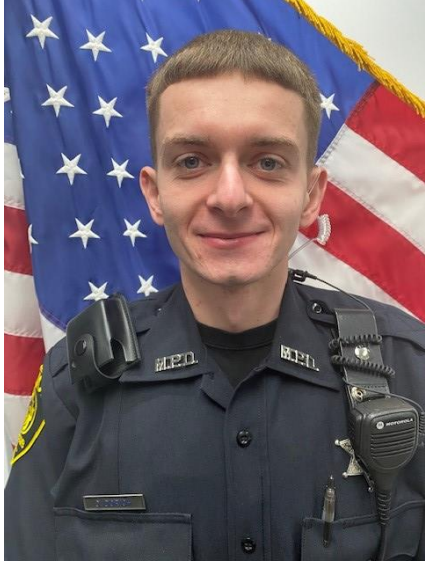

Officer Daniel Dorich was hired with the Department on May 8, 2019. Officer Dorich attended West Leyden High School and graduated in 2014. He attended Western Illinois University where he graduated with a Bachelors degree in Law Enforcement and a double minor in Economics and Homeland Security. Prior to getting hired by Macomb Police Department, Officer Dorich worked part-time for the McDonough County Sheriffs Office as Corrections Officer. Officer Dorich graduated from Police Training Institute in August of 2019 and was the validictorian of the class.



Officer Anthony Taylor was hired with the Department on August 5, 2019. Officer Taylor graduated from Bushnell-Prairie City High School in 2012. After graduation he enlisted into the Illinois Army National Guard and is currently serving as a Second Lieutenant with his Guard unit. Officer Taylor attended Spoon River College and later transferred to Western Illinois University and graduated with a Bachelors Degree in Law Enforcement and Justice Administration in May of 2019.

Promotions

With the retirement of Lieutenant Jason York there will be two promotions that will take place in January of 2020.

Officer of the Year 2019

The Police Officer of the Year award shall be bestowed upon one police officer annually in recognition of those qualities which distinguished him or her as a professional in the field of policing. It shall serve as proper recognition among fellow officers and the public alike for this individual's dedication to duty, outstanding job performance, unsullied moral character, exceptional community/civic leadership or service, professional police image and bearing. The Chief of Police makes the final selection among the nominations forwarded considering guidelines outlined in policy.

Officer Nick Severs has been with the Macomb Police Department since June 2016. Officers Severs has proven to be a role model to Officers on the department, a leader, and a great liaison between the community and the department. Officer Severs was instrumental in helping reestablish the Macomb Police K9 program by assisting with fundraising within the community and gaining overall support from area businesses to get the program back up and running. While being the department K9 handler, Officer Severs had been involved in the seizure of 61 items of contraband including \$9000 worth of electronics. Officer Severs has conducted numerous K9 demonstrations and has contributed to at least 93 arrests in the short time of being the K-9 Officer. Officer Severs has bettered the community by spearheading the Macomb FOP Shop with a Cop program for the past three years. During that time, he has organized and volunteered his time to help many underprivileged families in the Macomb Community. Officer Severs has been instrumental in assisting State Legislators in drafting new legislation to ensure the use of drug sniffing canines would not be adversely affected by the legalization of cannabis. Officer Severs was named the Officer of the Year 2019.

Awards and Commendations

Letters of Commendation

Letters of Commendation are issued to any employee of the Macomb Police Department to acknowledge a sustained effort or particular act resulting in an arrest or planned improvement of operations or techniques which displayed a dedication to the public safety or welfare and reflected favorably on the officer and the department.

This year the department issued three Letters of Commendation to officers for outstanding service.

Officer Tom Duvall

Officer Duvall and another Officer responded to a local motel where they were able to locate a young female in distress. The female had taken an unknown narcotic and was not responding to officers. Officer Duvall assisted with giving the female a dose of Narcan. The female did not respond and was given additional doses of Narcan to get a response. Due to the fast reaction by Officer Duvall the female subject survived her encounter.

Officer Todd Tedrow

Officer Tedrow responded to a local motel where he and another officer were able to locate a young female who was in distress. The female had taken an unknown narcotic and was not responding to officers. Officer Tedrow gave the female an initial dose of Narcan. The female did not respond and was given additional doses of Narcan to get a response. Due to the fast reaction by Officer Tedrow the female subject survived her encounter.

Officer Nick Severs

In April of 2019 Officers Severs was dispatched to a Macomb Fire Rescue call for a subject that was unconscious. Once Officer Severs arrived, he noticed that the male subject was bleeding from the nose and was able to ascertain that the subject had taken an unknown amount of Oxycontin and had previously overdosed on a prior occasion from this as well. Officer Severs retrieved the Narcan from his vehicle and was able to assist in administering the drug. After a short time period the subject began to react to the Narcan and awoke.

Meritorious Service Award

This award is for creditable accomplishment, bringing public or professional acclaim to himself or herself, to the department, or the police profession, as a result of showing initiative, devotion to duty or service to the public. During 2019, Chief Barker gave one of the Meritorious Service Awards to a deserving officer.

Lieutenant Jason York

Lieutenant Jason York has served with the Macomb Police Department since January of 2000. Since his employment he has enriched countless department programs and greatly contributed to the overall professionalism of the Macomb Police Department. Lieutenant York coordinated and implemented the department's first Citizens Police Academy. Lieutenant York took it upon himself and worked on the Citizens Police Academy which the department has never had prior. Lieutenant York oversaw the teaching and coordination of all six of the Citizen Police Academy classes that have been held at the department. This Academy has shown countless citizens what is done within the department and is a positive interaction with the community. Lieutenant York also developed and implemented the Honor Guard for the department. Lieutenant York served as the Commander for that division since its reintroduction in 2015. Lieutenant York also served tirelessly on the Crime stoppers board for 10 years, representing the department in that capacity. Lieutenant York's humble demeanor, light-hearted humor, and willingness to help others represents the very best traits of a police officer. His relentless efforts to improve the agency, programs, and services provided to the citizens of Macomb uphold the highest standards of the organization and bring great credit upon him and the Macomb Police Department.

2019 in Summary

Highlights of Major Cases

The Macomb Police Department continues to have success in keeping Macomb safe. Whether it's a call originating with a patrol officer or a case that the investigations division is following up on MPD has been successful in solving a number of criminal cases of significance.

Possible Assault at Complex

In April Officers responded to a local apartment complex where a subject indicated that they had been attacked. Officers arrived and secured the scene for investigations to come out due to the extended of the accusations. Officers and Investigators looked over the scene as the victim was transported to McDonough Hospital. After looking at the scene and determining that the victim had no injuries after saying they had been hit in the head from behind. The subject was questioned and admitted that they had made up the entire attack. It was later determined that this subject had filed false reports with other departments on prior occasions.

3 Robberies with One Suspect

In early June Officers responded to N Lafayette St to meet with a victim that had been jumped by 6-7 subjects. The victim indicated that one of the subjects had a handgun and had pistol whipped the victim. As information became available it was later determined that the victim was purchasing Cannabis from a subject that he knew. The subject walked up to the victim and hit him in the head with the handgun. The victim got into his car and fled the scene as he was being approached by the group of subjects. The subject was later arrested.

In early July Officers responded to an apartment complex where two subjects claimed that they were attacked in their car and robbed. The suspect had pointed a gun at them during the robbery. The two victims said that they were going to give a ride to a subject that they knew. That subject arrived along with another subject. One of the subjects pointed a gun at them and took their purse out of the car. The subject was later arrested.

In September, Officers were dispatched to an apartment complex on the west end of town in reference to a battery report and theft. The victim informed officers that he had given a friend a ride to the apartment complex. When they arrived two subjects sat in the back seat of the car and eventually grabbed his car keys, punched him in the face and fled on foot. A photo lineup was conducted with the victim identifying the suspects. The suspects were later arrested and charged with Robbery and Theft.

All three of these Armed Robberies had the same suspect in the case.

Armed Robbery

Officers were dispatched to area of Madelyn Ave for and armed robbery where the victim's phone was taken. The victim said that he was standing on the sidewalk in that block. Two subjects came up to him and stuck him in the head with a gun and stole his cell phone. Officers arrived and was able to locate the suspects within minutes of the call. One of the suspects was a juvenile and one of the subjects was an adult. The Officers were later able to determine that the subjects had used a BB gun during the theft. One of the suspects still had the BB gun in his waist band when stopped by officers.

Counterfeit Credit Cards

In March an officer while on patrol stopped a vehicle for driving backwards in the roadway. Once the officer made contact with the occupants, the vehicle had a strong odor of cannabis inside. The officer was able to search the vehicle and located raw cannabis along with a credit card programmer that was hidden in a compartment. Detectives later interviewed the subjects and determined that they had been using the credit card programmer to take stolen credit card numbers and make fake cards. They were utilizing these cards to purchase fuel at gas stations.

Business Burglaries

On June 6th Macomb Police Officers were dispatched to Farm King on E Jackson St in reference to a burglary that had taken place. Officers were able to determine that two juvenile subjects had entered the store and took ammunition. The subjects had attempted to steal guns but was unable to break the glass on the gun case to get access. Video inside the store was able to capture the subjects while in the store.

On June 7th Detectives were following up on a burglary that took place at Pawn Plus on W Jackson St. This location had video as well. The suspects had broken out the front window and gained access to the guns behind the counter. In this burglary the suspects were able to take two AR-15 rifles and flee the location. Using video surveillance at other locations Detectives were able to narrow down the suspects and determine who they were. Both juveniles were arrested without incident.

Arson Case

In June Officers were dispatched to W Murray St in reference to a car fire. Upon arrival officers determined that a side window to the car had been busted out. No one on scene had damaged the window. The car was a complete loss due to the fire. The fire department believed this to be an arson case. Detectives were able to develop leads due to this case being related to several auto burglaries that took place that same night. One adult and two juveniles were eventually charged with Theft from an Auto and Arson.

Aggravated Battery and Stabbing

In September Officers responded to Wal Mart in reference to an employee that was involved in a fight with a customer. Upon arrival Officers were informed that the suspect had stabbed the employee and that he was standing at the service desk as Officers arrived. Officers made contact with the suspect who did not follow commands to get on the ground. Officers had to subdue the suspect and take him into custody. In reviewing the video of the incident Officers could see that the fight had started in the Men's restroom and moved out into the main area of the store. The suspect had the employee on the floor and was on top of him attempting to stab the employee. The employee sustained minor cuts from the incident.

Department Programs

Strategic Response

The Strategic Response Team conducted 7 operations in 2019. 6 were narcotics search warrant executions and one was responding to Fulton County to assist The Fulton County Sheriff's office with an officer down call. The Strategic Response Team logged 58 hours of training for 2019. Due to Officers leaving the department in 2018, we were able to add two new members in 2019.

Pride in Policing

Robert Depoy Firearm Range

During the last year the Macomb Police Department range was used by the Macomb Police Department, WIU Office of Public Safety, McDonough County Sheriff's Office and the Illinois State Police District 14. The training over the last year has included handgun qualifications, rifle qualifications and basic training for both handgun and rifle. The range has also been used for the Special Response Team for search warrant service and practice. The McDonough County 4H Center uses the range during the summer months to teach classes to area youth.

D.A.R.E./SRO



D.A.R.E. (Drug Abuse Resistance Education) is a collaborative effort by D.A.R.E. certified law enforcement officers, educators, students, parents, and the community to offer an educational program in the classroom to prevent or reduce drug abuse and violence among children and youth. The emphasis of D.A.R.E. is to help students recognize and resist the many direct and subtle pressures that influence students to experiment with alcohol, tobacco, marijuana, inhalants, or other drugs, or to engage in violence.

The ten-week program offers preventive strategies to enhance those protective factors - especially bonding to the family, school, and community - which research has shown to foster development of resiliency in students who may be at risk for substance abuse or other problem behaviors. The Macomb Police Department's D.A.R.E. program started in the mid-1980's and has had several instructors since its introduction.

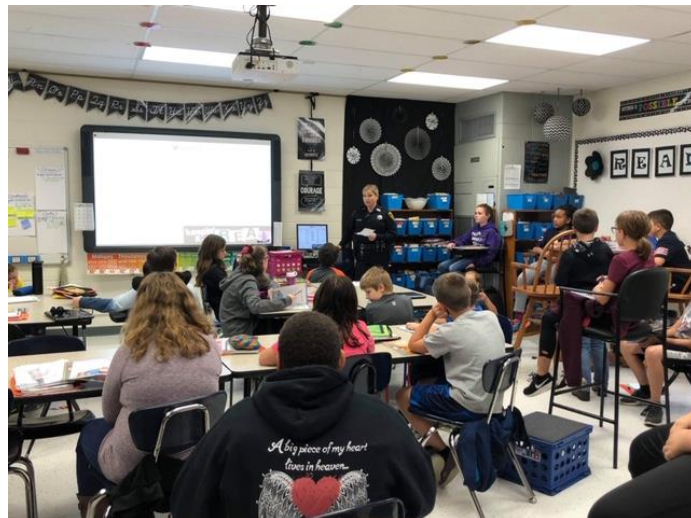
The **School Resource Officer (S.R.O.)** should be viewed as a resource to which the school community can rely on as a law enforcement officer, a law-related counselor, and a law-related teacher. The S.R.O. not only keeps the peace in the schools but provides resource guidance to students, parents, faculty and staff, and educates through presentations a better understanding of our local, state, and federal laws.

The S.R.O. also serves as a positive role model for the students at school during school hours and off the school grounds at extracurricular activities. Officer Matt Marass worked as the SRO for 1

year. At the beginning of the 2019/2020 school year the Department switched Officers to fill this role due to Officer Marass leaving to take a fulltime job with the Military. Officer Denise Cremer became the School Resource Officer starting in August of 2019.

The Macomb Police Department organized a formal honor guard in 2015. Made up of volunteer officers these officers are able to present the American flag at events or funerals and support other formal functions with their services. In 2019 the Honor Guard participated in several local events throughout the year.

In November the Macomb Police Honor Guard stood overwatch on the casket of our first African American police officer hired in Macomb, William “Bill” Thorpe (86). Sgt. Thorpe joined the Macomb Police Department in 1962. He rose to the rank of Sergeant and retired at that rank in 1984 with 23 years of service. Sgt. Thorpe also served in the US Army from 1951 to 1955 serving in the Korean War. The City of Macomb will miss Sgt. Thorpe deeply, but appreciate his dedication to the citizens of Macomb.

Macomb Police Explorers Post #4044

The mission of the Macomb Police Explorer Post is to educate and mentor young men and women who are interested in the field of law enforcement and provide an environment which impresses the importance of community service, responsibility, and teamwork upon them.

The program provides both lecture and hands-on training opportunities for youth and young adults (age 14-20) and fosters a professional learning environment amongst explorers and post advisors. The program operates on an internal rank structure, which, by design, places explorers in leadership positions and gives them ownership in the program, the department, and their community.

Explorers are supervised by advisors, sworn law enforcement officers who oversee the program. Last year the post was able to implement the role of co-advisors and Cadets to those who met certain criteria and whom were aging out. These unsworn cadets receive more in-depth law enforcement training and assist in coordinating special events and running meetings and other trainings.

The program currently has 13 cadets and explorers representing student bodies of Western Illinois University, Spoon River College, Macomb High School, and Bushnell-Prairie City High School. As a testament to the program, in the past several years explorers were hired by multiple different agencies including: The Macomb Police Department, Illinois State Police, Rockford Police Department, Beloit, WI Police Department, Rantoul Police Department, Elk Grove Police Department.

Last year, the program raised over \$2,200 in donations from car washes, waiting tables at local restaurants, and a firearm raffle. These contributions made the purchase of training aids and new digital radios possible. These purchases enhance the quality of training explorers are able to receive, and enable explorers to communicate with department members during community events and in case of natural disasters.

This past year post members supported countless different community events, providing over 250 hours of community service to include Shop with a Cop, WIU and MHS Homecoming parades, Heritage Days, and WIU Haunted Trail just to name a few. It is with the support of the community to make the program run fluidly and successfully. Over 60 awards were handed out to post members between the spring and fall award ceremonies in recognition of their achievements and commitment to the community.

Explorers meet every week for two hours during the fall and spring semesters and cover numerous topics to include use of force, Miranda Rights, traffic control, building searches, traffic stops, and courtroom testimony just to name a few.

Vehicle Impoundment Program

The Vehicle Impoundment program continues to be successful in utilizing new state legislature that allows police departments to impound vehicles for certain violations. The violations included are primarily safety and licensing violations such as Driving Under the Influence of Alcohol, Driving While License Suspended/Revoked, fleeing a Police Officer, Drug Offenses, or Leaving the scene of an Accident. Over the past five years, the Macomb Police Department has had a high level of success in utilizing the program. In 2019 there were 140 vehicles impounded under the program.

The Macomb Police Department's enforcement of the above violations along with the subsequent towing and impoundment of the offender's vehicle is a continuous effort to make the roads safer for the law-abiding motoring public. In 2009 at the beginning of the program the Macomb Police Department handled 118 hit and run accidents. In 2019 only 72 hit and run accidents were reported.

ILEAP Accreditation

The department remains professionally accredited by the Illinois Association of Chiefs of Police through their Illinois Law Enforcement Accreditation Program (ILEAP). The ILEAP Accreditation award symbolizes the department's achievement in excellence. The agency has reached a level of professional esteem through audits, inspections, and peer critique in an effort to maintain the best practices in the field of policing. The department has been accredited since October of 2012 and recently completed the re-accreditation process in December of 2017.

In April of 2018 the Macomb Police Department became a Tier 2 accredited agency. We are one of a few agencies in the state with this distinction.

Social Media Initiatives

Facebook serves as our main Social Media vehicle with about 10,186 "Likes". Typical posts by Macomb Police on FB reach 3000 to 10,000 viewers. The most popular posts this year were the "Follow the Bus" detail in conjunction with WGEM News follow-up. Building followership becomes important in times where we need to broadcast a message and reach a lot of people.

Citizens Police Academy

The Macomb Police Department conducted our Citizen's Police Academy in the Spring and Fall of 2018. The 10-week program met once a week and exposed participants to many aspects of law enforcement. As of 2019 we have held 6 CPA classes with a total of 97 people graduating.

Participants spent time learning about many areas of the department including, but not limited to, the use of force, criminal law, evidence and criminal cases, as well as the department's Strategic Response Team, and K-9 and Field Training Programs. Participants also gain a unique inside look at MPD facilities, equipment and got to meet the officers that keep our community safe.

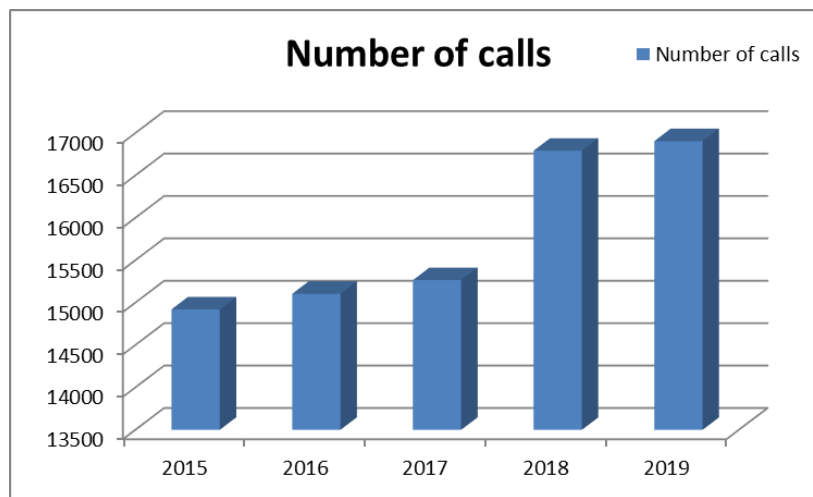

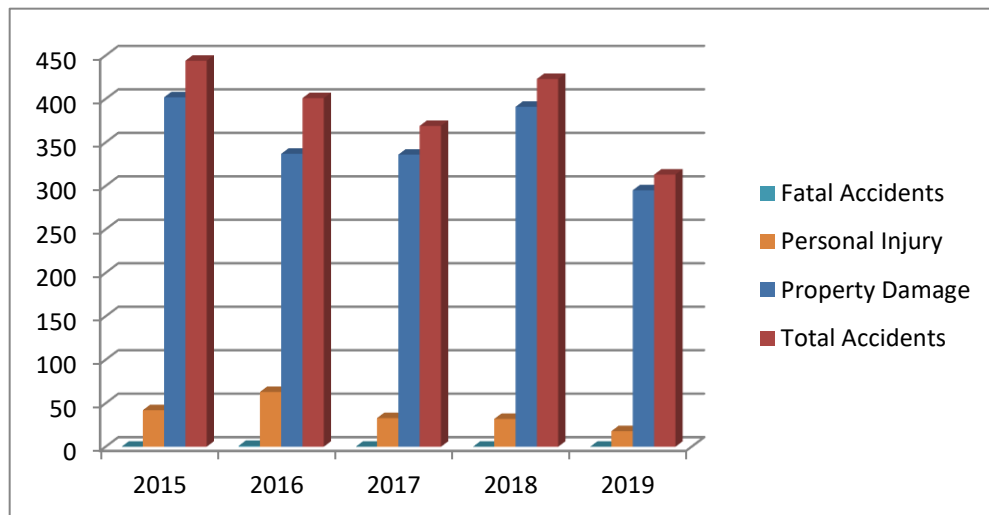

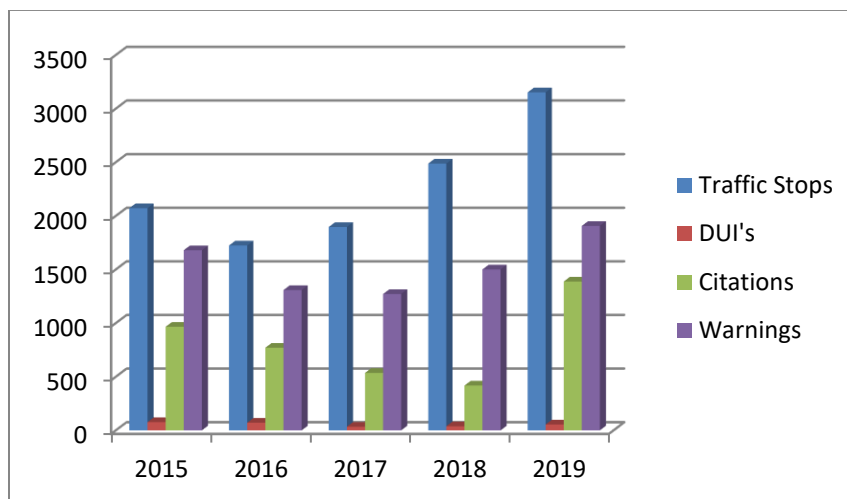

2019 Polar Plunge

A polar plunge is an event held during the winter where participants enter a body of water despite the low temperature to raise money for a charitable organization. In years past, officers would drive up to Galesburg to participate in a polar plunge which benefited Special Olympics. In 2017 the Macomb FOP Lodge 189 held their own Polar Plunge at Spring Lake. The inaugural event in 2016 drew 200 or more people in its first year. This year's polar plunge raised \$3,500 from our department and over \$14,000 for Special Olympics. In 2019 the Special Olympics moved the event to the Western Illinois University property and had a tank that everyone got into.

Special Olympics is an international organization that changes lives by promoting understanding, acceptance and inclusion between people with and without intellectual disabilities. Through year-round sports training and athletic competition and other related programming for more than 3 million children and adults with intellectual disabilities in more than 180 countries, Special Olympics has created a model community that celebrates people's diverse gifts. Founded in 1968 by Eunice Kennedy Shriver, Special Olympics provide people with intellectual disabilities continuing opportunities to realize their potential, develop physical fitness, and demonstrate courage and experience joy and friendship. The law enforcement community presented Special Olympics Illinois with a check for over 5 million dollars in 2019.

Big Brothers Big Sisters

Several members of the Macomb Police Department have volunteered their time to the Big Brothers Big Sisters program. The mission of the Big Brothers Big Sisters program is to provide children facing adversity with strong and enduring, professionally supported one-to-one relationships that change their lives for the better, forever. Officers also participate in the Bowl For Kids Sake bowling event to raise money for the Big Brothers Big Sisters program.

Dunkin Donuts Cop on Rooftop

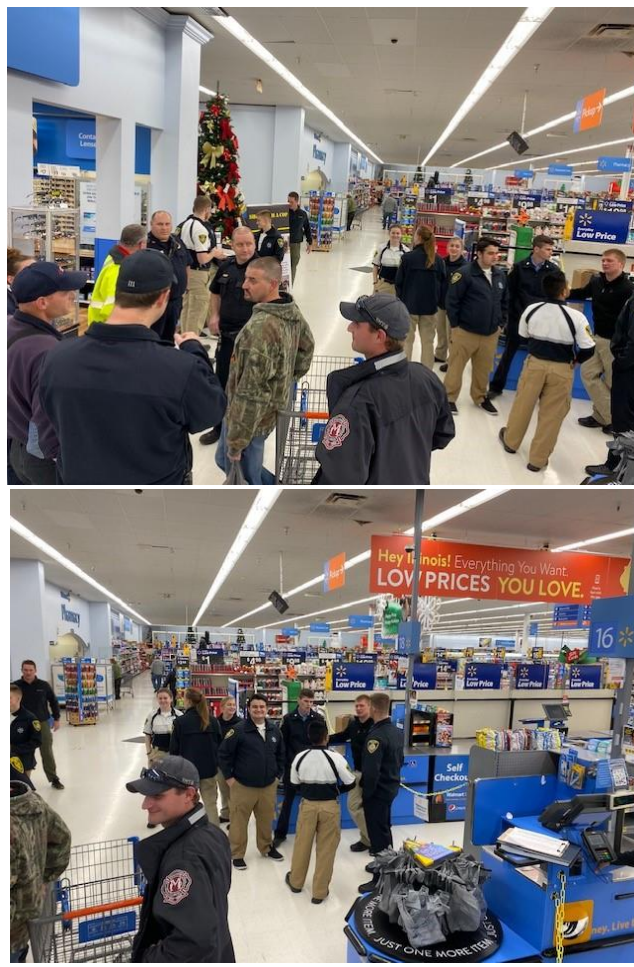
