Equal Opportunity in Employment & Housing

Complaint Process

If you have a concern about unfair treatment in employment or housing, you may file a complaint in writing with the City Administrator within 30 days of the incident.

Membership will be comprised of one member with housing-related expertise, one member of a minority group, one member from the local branch of the NAACP, one member from the ministerial alliance, and five at-large members appointed by the mayor with the advice and consent of the City Council.
